CALL FOR RESEARCH ABSTRACTS:

The Canadian Medication Appropriateness and Deprescribing Network (CADeN) is a group of clinicians, educators, people with lived experience, policymakers, and researchers. We work together to produce, share, and apply information to promote the safe and appropriate use of medications. We will be hosting a National meeting on November 8th and 9th, 2023 at the Hotel Omni Mont-Royal in Montréal, Canada (1050 Sherbrooke West, Montréal, QC H3A 2R6) to showcase efforts to improve appropriate prescribing across the country.

We are offering the opportunity to submit your work related to appropriate prescribing for presentation. We encourage abstract submissions related to all types of research (e.g., clinical trials, quality improvement, quality assurance/assurance, qualitative research, epidemiology, pharmacoepidemiology) and education efforts. Research presented at another conference is eligible for submission. While we encourage abstract submissions of work in varying stages of completion, results should be available for the symposium in November.

*For fairness, we have defined trainees (self-identified) as undergraduate students; post-graduate students at the master's level (or candidate); PhD candidates; medical, nursing, pharmacy students; clinical fellows (PGY-4-5).

*Non-trainees include (self-identified) PGY6 or higher clinical fellows; post-graduate research fellows; faculty members; practicing licensed clinicians or educators.

Deadline for abstract submission **August 16, 2023, 11:59pm EST.**

Successful abstract presenters will be contacted by **September 14th, 2023.**



Instructions:

Track 1: Trainees* are asked to submit a research abstract of 250-words (not including title, author names, or affiliations). Abstracts can be submitted and presented in either French or English.

Title, list of authors, name of person who will attend the meeting in person and present the abstract (must be a trainee), background, aim, methods, results (or planned results- must have results by the time the meeting takes place), discussion, conclusion.

Please note that abstract presentations for Track 1 are in POSTER format (instructions for poster formatting will be provided when successful abstract presenters are notified). The poster session is judged with prizes awarded to top presenters.

*For fairness and in accordance with the guidelines of the Canadian Institutes of Health Research, the allowed word count is higher for the French submission

Track 2: Non-trainees* are asked to submit a research abstract of 250-words (not including title, author names, or affiliations) for a proposed oral abstract:

Title, list of authors, name of person who will attend the meeting in person and present the abstract (must be a trainee), background, aim, methods, results (or planned results- must have results by the time the meeting takes place), discussion, conclusion.

Abstract presentations for Track 2 are ORAL format. Oral presentations can be submitted for one of two types of presentations (please indicate on the submission form):

1. Short snapper (10-minute presentation followed by 5-minutes of audience interaction); 4 spots available. 1 guaranteed spot for an early-career researchers (within first 5 years of practice).
2. Full-length (25-minute presentation followed by 5-minutes of audience interaction); 2 spots available.

Oral abstract presentations are not judged.
